Honourable Excellencies,

The European Roma Rights Centre (ERRC),<sup>1</sup> the Federazione Romani,<sup>2</sup> and Idea Rom Onlus (Idea Rom)<sup>3</sup> are writing to express concern about the reports of a violent arson attack on a Roma camp which took place on 10 December 2011 in Turin.

According to the ERRC partner organisations based in Turin, hundreds of people marched to the informal Roma camp at Via Continassa, and started setting fire to shacks, caravans and cars. The attack was apparently sparked by a rape allegation against two Romani men. The individual who made the accusation later reportedly retracted her accusation. The whole camp was destroyed, including the homes and property of the 46 Romani individuals living there. Eyewitnesses also reported that a flyer was posted before the attack, calling on residents to 'clean up' the area of Roma. Local media and eyewitnesses confirmed that a public official, the president of the fifth district, was present at a demonstration that preceded the violence.<sup>4</sup>

The ERRC, Federazione Romani and Idea Rom are calling on the police and prosecutor in Turin to ensure that all crimes are investigated promptly and impartially, and to ensure that racial motivation is fully considered.

The victims of this attack were members of the Romani minority, and given the circumstances, it is possible that a racially-motivated crime, or hate crime, has been committed. Thus, the full investigation of these incidents and prosecution of the perpetrators is a matter of protecting the rights of both the individuals affected and the entire Romani community. A successful investigation and resolution of this case will bring justice to the victims in accordance with Article 13 of the European Convention on Human Rights which stipulates that everyone whose rights and freedoms (which include the right to liberty and security of person and freedom from inhuman or degrading treatment) have been violated shall have effective remedy before a national authority.

Given the importance of the incident outlined above, the undersigned organisations, in accordance with the Italian act on the freedom of information,<sup>5</sup> respectfully request your offices to provide the following written information:

- Has an investigation into this incident been opened and which investigative measures have and will be undertaken by your office to identify the perpetrators?
- What measures will be taken by your office to ensure accountability and to give full protection to victims?
- In addition to the two people arrested after the attack have you identified other individuals suspected to have organised or participated in the incident?
- Has anyone been charged in connection to this incident and which charges have been brought against them?

We look forward to hearing of your progress, and thank you for your efforts to conduct a fair and prompt investigation of this case.
