Dear Mayor Alemanno, Prefect Pecoraro, Councillor Belviso, Delegate Ciardi,

The European Roma Rights Centre¹ and Popica ONLUS² are writing to express deep concern about the ongoing evictions and ill treatment of Romani communities in Rome in recent months.

On 11 August 2011, the ERRC and Association 21 luglio sent a letter to Rome authorities expressing concern about the continuing forced evictions of Romani communities.³ Since then, 18 more evictions have been documented by the ERRC and local organisations. The majority of the evicted families have been living in Rome for many years, have been subjected to multiple evictions and are presently living on the streets, as no alternative accommodation was provided by the municipality. Many children were prevented from attending school as a consequence of the eviction. For example:

- On 29 September, almost 200 Romanian Roma were evicted from the settlement of via Salaria;⁴
- On 8 October, four evictions were carried out in the same day, affecting about 231 Roma living in informal settlements in the district of Statuario-Capannelle and in a building owned by the Municipality in via Castrense;⁵
- On 17 October, 22 Romani adults and 12 Romani children were evicted in the settlement of via Palaia;⁶ and
- On 18 October, 15 Roma were evicted from a private building called via Pierantoni.⁷

The ERRC and Popica ONLUS are deeply concerned about the fact that families are evicted without written notification in advance or consideration of the personal situations of those affected. Moreover only temporary solutions are offered to the families, such as shelter only for women and children or assisted returns for citizens of other EU states. During the evictions, the residents' personal belongings are often destroyed. On 11 September, ERRC staff met some of the families who were evicted from tents, which had been cut and destroyed three times during one week. These families reported that racist remarks were made by a police officer during the evictions. Moreover families explained that they are afraid to walk together around the city as they have been targeted and followed by the police.

According to Popica Onlus, a local Romani organisation that has been monitoring evictions, many complaints were made to the authorities regarding the vulnerability of the families to repeated evictions. The Municipality has started to consider admitting some of the evicted families whose children are enrolled in school into shelters. However evictions often prevent children from being enrolled in school, and leave pregnant women and the elderly in increasingly vulnerable situations.

As noted in our 11 August letter, numerous violations of fundamental human rights arise during the process of forced evictions of Roma. The authorities in Rome continue to ignore the right of Roma to adequate housing and protection from forced eviction, the right to protection of private and family life and the freedom from inhuman and/or degrading treatment. Moreover, these evictions are discriminatory, in violation of the international law.⁸

The ERRC and Popica ONLUS are concerned about reports indicating that further evictions will take place in Rome and urgently call on you to implement the following recommendations:

- Immediately provide shelter, particularly to the families who have children enrolled in school, and ensure that adequate alternative accommodation is provided with the ultimate aim of identifying permanent and adequate housing within the municipality to all evictees;
- Refrain from conducting evictions of Roma without adequate notification and due process;
- Provide an opportunity for genuine consultation with those affected;
- Ensure that the individuals affected be given compensation for lost property and other damage associated with the forced eviction and destruction of property;
- Ensure that no Romani individual is made homeless in the process of eviction;
- Ensure effective investigation of allegations of police abuse during the evictions;
- Consult Romani and Sinti organisations in order to develop sustainable, adequate integrated housing solutions for all Roma and Sinti on the territory of Rome; and
- Implement complex housing, employment, education and health projects to promote real inclusion of Roma in Rome.

We request to be informed of any actions undertaken by your offices.
