**Re: Attack against Roma relocated from Belgrade's Belvil settlement**

Dear Sirs/Madam,

The European Roma Rights Centre (ERRC)<sup>1</sup> is writing to express deep concern about the 1 May 2012 attack on Roma in the Belgrade settlement, Jabučki Rit. The victims of this incident were Romani individuals who had been forcibly evicted and relocated from Belgrade's Belvil settlement by city authorities on 26 April.

According to media and NGO reports, on 1 May at around 9:00 AM, a group of between 15 to 20 masked individuals attacked the settlement, shouting racist slogans including "Serbia for Serbs, Roma out of Serbia." They also drew a swastika on one of the metal containers to which the Roma had been relocated.<sup>2</sup> To date, only one suspect has been arrested; a resident of Jabučki Rit.<sup>3</sup> Since the Roma were forcibly relocated, relations have deteriorated between the relocated Roma and their new neighbours.

Serbia is legally obligated to respect, protect and fulfill the right to adequate housing as defined in the International Covenant on Economic, Social and Cultural Rights (ICESCR, Article 11) and the right to be free from unlawful interference in the home under the International Covenant on Civil and Political Rights (ICCPR, Article 17). The United Nations Committee on Economic Social and Cultural Rights, which oversees implementation of the ICESCR, has elaborated that "Evictions should not result in individuals being [...] vulnerable to the violation of other human rights."<sup>4</sup> Article 16 of the Serbian Constitution sets out that "ratified international treaties shall be an integral part of the legal system in the Republic of Serbia and applied directly."<sup>5</sup>

The ERRC requests that Belgrade police and prosecutors fully investigate the attack, including its racial elements, identify and bring to justice all perpetrators, and ensure full assistance and compensation to the affected persons. We request that Belgrade city authorities provide adequate and appropriate protection to all forcibly relocated Roma from the Belvil settlement, and ensure that any re-housing plans include appropriate measures to ensure the safety of the affected Roma and foster real integration and inclusion in their new locations.
